Awareness of environmental protection of production and business establishments in industrial parks is still limited, many owners of establishments do not understand clearly, are not accurate and even do not update the provisions of the

current law in the area. environmental protection work.

Hoa Binh Sugar Factory polluting the Buoi River or the suspected discharge of waste in Ha Tinh are just two of many scandalous environmental violations involving businesses in Vietnam in recent years.

Hyundai - Vinashin discharge waste into Van Phong Bay.

In April 2011, the Police Department for Environmental Crime Prevention (PC49), Khanh Hoa Provincial Police caught the Hyundai - Vinashin Shipyard Co., Ltd. (HVS) discharging liquid waste that has not yet been treated by the treatment system. to Van Phong Bay. HVS is a joint venture between Hyundai Group (Korea) and Vietnam Shipbuilding Industry Corporation.

During the inspection at HVS, the environmental police force discovered that there was no waste treatment system in the canteen area 4 (used for about 1,000 workers). All waste from the canteen, including toilets (basement) is discharged directly into the sea at the port number 3. According to calculations, the amount of dirty waste discharged into the sea is 25m3 per day and night.

Next is the case of Vedan polluting Thi Vai river:

According to the initial testimony of Vedan's leaders, the amount of post-fermentation wastewater that the factories of this company discharges directly into the Thi Vai River is only approximately 45,000 m3 per month. However, the number that the inspection team concluded was more than double, 105,600 m3 a month.

The Ministry of Natural Resources and Environment has transferred the dossier and requested the People's Committee of Dong Nai province to direct the handling in accordance with the law, and at the same time, requested Vedan Company to install flow measurement equipment and automatic monitoring of some environmental parameters. typical contamination in wastewater after treatment,

periodically record measurements and report results to the Department of Natural Resources and Environment of Dong Nai province for monitoring and supervision.

Hanoi, November 17, 2020

THE LAW

ENVIRONMENTAL PROTECTION

Article 38. Responsibilities of agencies appraising environmental impact assessment reports

- 1. Take responsibility for the appraisal results and decide to approve the appraisal results of the environmental impact assessment report.
- 2. Publicize on the portal the decision approving the appraisal results of the environmental impact

assessment report, except for information classified as state secret or enterprise secret as prescribed by law.

3. Build and integrate the database on environmental impact assessment into the national environmental database.

Section 4. ENVIRONMENTAL LICENSE

Article 39. Subjects requiring an environmental permit

- 1. Group I, Group II and Group III investment projects that generate wastewater, dust, and exhaust gases discharged into the environment must be treated or generate hazardous wastes must be managed according to regulations on quality management discharged when put into official operation.
- 2. Investment projects, establishments, concentrated production, business and service zones, and industrial clusters operating before the effective date of this Law have the same environmental criteria as those specified in Clause 1 of this Law. This.
- 3. The subjects specified in Clause 1 of this Article in the case of urgent public investment projects as prescribed by the law on public investment are exempt from environmental permits.

Article 40. Contents of environmental permits

1. Contents of an environmental permit include general information about investment projects, establishments, production and business zones, concentrated services, and industrial clusters; environmental licensing content; requirements on environmental protection; the term of the environmental permit; other content (if any).

2. Contents of an environmental license include:

a) Source of wastewater generation; maximum wastewater discharge volume; wastewater stream; pollutants and limit values of pollutants in the wastewater stream; location, method of wastewater discharge and wastewater receiving source;

- b) The source of emissions; maximum exhaust gas flow; exhaust flow; pollutants and limit values of pollutants according to the flue gas stream; location and method of exhaust gas discharge;
- c) Sources and limit values for noise and vibration;
- d) Hazardous waste treatment facilities and equipment systems; hazardous waste code and volume allowed to be treated, number of hazardous waste transfer stations, operating area for investment projects, establishments providing hazardous waste treatment services; dd) Type and volume of scrap permitted to be imported, for investment projects or establishments that import scrap from abroad as raw production materials.

3. Requirements on environmental protection include:

- a) Having works and measures to collect and treat wastewater and exhaust gas, and to minimize noise and vibration meeting requirements; in case of discharge of wastewater into irrigation works, there must be requirements on environmental protection for water sources of irrigation works;
- b) There are measures, systems, works and equipment for storing, transporting, transhipping, preliminarily processing and handling to meet the requirements of technical and management processes for investment projects and implementation establishments. hazardous waste treatment services;
- c) Having warehouses and storage yards for scrap meeting regulations; recycling equipment system; impurity treatment plan; re-export plan, for investment projects, establishments that import scrap from abroad as raw production materials;
- d) Having a plan for environmental management and monitoring, a plan for prevention and response to environmental incidents; equipment and works for prevention and response to environmental incidents, environmental monitoring;
- e) Management of daily-life solid waste, ordinary industrial solid waste and hazardous waste; environmental renovation and restoration;

compensate for biodiversity in accordance with the law:

f) Other requirements on environmental protection (if any).

III. DISCUSSION AND CONCLUSION

The planning for the development of industrial zones in some localities is still rampant, while the ability to attract investment capital is low and financial capacity is still limited, leading to a lack of investment in infrastructure construction.

In the process of industrialization and modernization of the country, the task of environmental protection has always been respected by the Party and State. Directive No. 36-CT/TW dated June 25, 1998 and followed by Resolution No. 41-NQ/TW dated November 15, 2004 of the Politburo on strengthening environmental protection in the period of industrialization, The modernization of the country has given very important orientations, which emphasize that urban areas and industrial zones must well implement waste treatment plans, giving priority to hazardous waste treatment.
