# ABSTRACT

The study aims are to assess the knowledge of nursing students regarding anecdotal records and to identify the relationship between the knowledge level and socio demographic variables of  $II^{nd}$  Year BSC nursing students. The quantitative research approach and cross sectional descriptive design was adopted for the study. The study was conducted in Narayana College of nursing in Nellore. 30  $II^{nd}$  Year BSC nursing students were selected by using Non Probability Convenience Sampling Technique. Structured Questionnaire method was used for collecting the information from samples. Data analysis done by using descriptive and inferential statistics. The results revealed that 7(23%) had moderately adequate knowledge and 23(77%) students had inadequate knowledge regarding anecdotal records. The study concluded that majority of students has inadequate knowledge regarding anecdotal records to nursing students.

Anecdotal notes are used to record specific observation of individual student behaviors, skills and attitudes as they relate to the outcome in the program of studies. Such not provide cumulative information on student learning and direction for further instruction. Anecdotal notes are often written as the results of ongoing observation during the lessons but may also be written in responding to a product of performance the student has completed. They are brief, objectives and focused on specific outcome notes taken during or immediately following an activity are generally the most accurate.

### **II. METHODS AND MATERIAL**

Frequency and percentage distribution based on the level of knowledge among II<sup>nd</sup> Year BSC nursing students. regarding anecdotal records.


